Presentation „Schwerpunkt Außenwirtschaft 2015/2016“

Transatlantic Trade and Investment Partnership EU-US (TTIP)

Since the unanimous adoption of the mandate for negotiation by the 28 EU Member States, 13 negotiation rounds between the EU and the US on the so-called “Transatlantic Trade and Investment Partnership” or “TTIP” were held until now. The current issue of “Schwerpunkt Außenwirtschaft” focuses on TTIP. It covers economic and legal analyses of TTIP and offers explanations for the political dynamics of the negotiations. The institutional framework of the EU trade policy, the potential economic effects of TTIP, and the EU and US perspectives from a political-science angle are juxtaposed. The sectorial competitiveness of the Austrian export industry is studied as well as the value added of Austrian exports. The EU draft of the investment court is discussed. A prospective TTIP is compared with the Trans-Pacific Partnership (TPP) of the US with 11 Pacific States.
