The research conference will focus on social policy research in Austria and social policy research on Austria, analyses from a regional, national or comparative perspective, as well as in a European or global context.

Abstract submissions should include the following information:

- Title of the paper
- Name(s) of author(s)
- Abstract with information on background and research question, method or approach, results and discussion (maximum length: 300 words)
- Institution, e-mail addresses of the author(s)
